



2021-2022 OPERATING PROCEDURES

SCHOOL SCHEDULE

- In-person instruction will be provided 5 days a week
- Virtual Learning will only be available to students through Warren Connect. Students accepted into the virtual school will be full-time virtual students and will be enrolled in that program only. No athletics or extracurricular activities will be provided in the virtual program.

PREVENTION



COVID-19 CORONAVIRUS

- Teach and reinforce good hygiene measures such as handwashing, covering coughs, and distancing as feasible.
- Encourage social distancing practices, as needed.
- Post signage to communicate how to stop the spread. Include Covid-19 symptoms, preventative measures (including staying home when sick), good hygiene, and specific protocols.
- Clean/disinfect frequently touched surfaces at least daily and shared objects after each use.
- Take steps to make sure all water filling stations and features are safe.
- Ensure ventilation systems operate properly.
- Student seating should remain at least 3 feet apart, when feasible.



COVID-19 PROCEDURES

- Masks are recommended and encouraged for students and staff.
- Students or staff should isolate after a positive COVID-19 test following Tennessee Department of Health recommendations.
- Quarantine - Staff/students may quarantine at home for 10 days OR return to school with a mask requirement for 10 days as long as no symptoms exist.

SCHOOL BUILDINGS/PROCEDURES

Implement standard operating procedures while taking preventative measures such as:

- Provide hand sanitizer for students and staff.
- Limit unnecessary congregations of students and staff.
- Continue established Covid-19 protocol for students/staff who feel ill/experience symptoms when they come to school.
- Limit visitors and volunteers when students are present. Visitors will be limited to those invited by the schools.
- Students will eat meals in the cafeteria where proper hygiene and distancing (as feasible) will be encouraged.
- Lockers will be available. Encourage students to avoid congregating during class changes or by lockers.
- Conducting cleaning of hallways and high-touch surfaces throughout the school day.
- Large crowds for school assemblies or extracurricular activities will be allowed but will be encouraged to take preventative measures.
